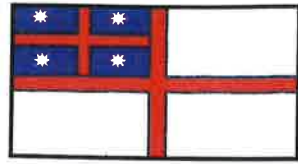

The Certified Rangatira - Chair for the Day is mutua James duVall, local Peace Officer - Mediator.

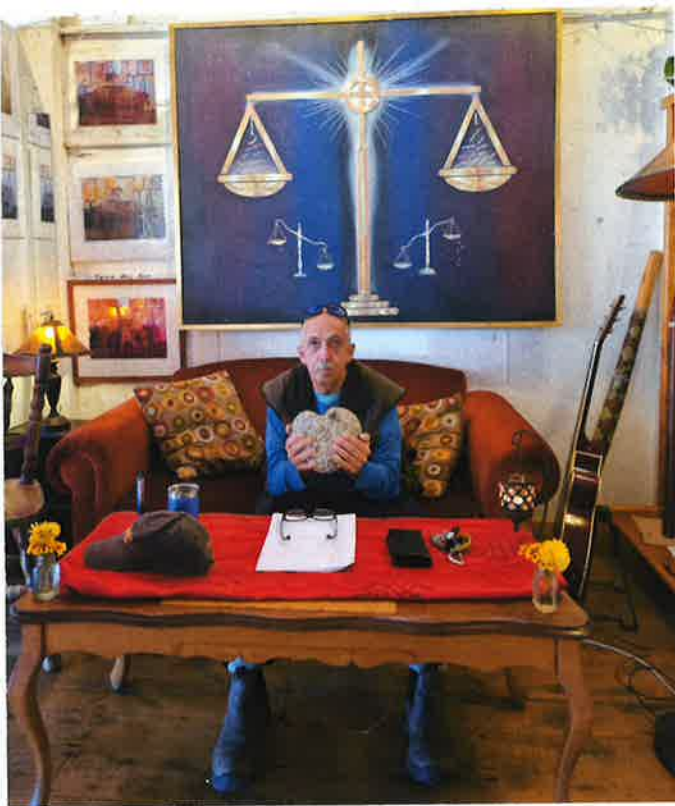
(hon. James CR.) Called upon anyone of the present Assessors to offer a hearty Karakia - Blessings. Robyn opened it and all sung into it...

(recorded) Then NgAngA called in Blessings from the Gold & Silver Rays of Creation. James CR. outlines the process of the Hearing;

- Parties involved identified
- Claims presented
- Evidence / Proof heard (spoken - written - video)
- Questions from the Assessors and Chairman.
- Open deliberate Floor sharing related to the Claims.
- Vote of Hands on Evidence / Proofs, confirmed by James CR.
- Resolution issued with Orders & Directives - Remedies for Peace.

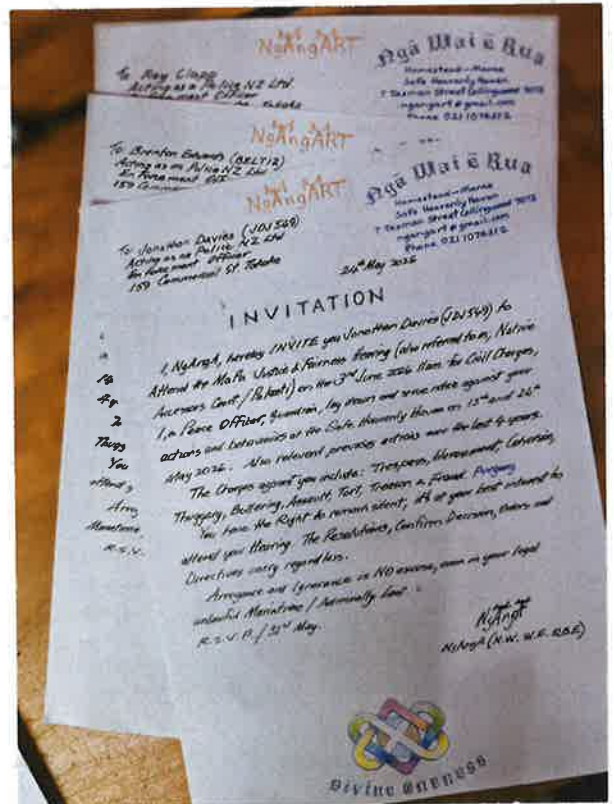

3 Police invites to their Hearing

**1. STALKING:** It was, interesting to note this Corped N.Z Parliament Business passed the Stalking Law on 26<sup>th</sup> May last week. into their septic system. These 3 Police offenders continue to Stalk by parking around the corner, guided by their deputy scouts, I believe, to ensure 1 AM alone, no witnesses, neighbouring businesses, with camera across the road. **3. HARASSMENT:** Constantly been tormented by these foolish actions from these 3 enforcing officers since this covidiot thing in 2020, without any real cause to do so. Anyone, who questions and stands up to their insanity are targeted, They like U to quitely comply to their lies.

**4. COERCION:** Fraudiciously attempts to joinder their FICTION CAPS name MCKENNEY to the Real Living NgAngA. Treats to arrest if they don't get a name on their data slave base.

(NgAngA) cont'.. On the 14<sup>th</sup> May BELT12 gave Me no choice coercing Me to sign with<sup>out</sup> duress (U.C.) on his note pad for Me to have the video transferred from My phone to his, to avoid him stealing & destroying it. They' coerce US to sign bail daily.

**5. PERJURY:** They, the 3, the Many, knowingly make False statements under oath, acting out of business. Using these man made up changing LegLIEsations, Acts to coerce, wrong Rights. P.C. cause. For example, cops given exemption to LIE to trap suspects? Hiding a breach of Term & Conditions on our Identity documents. - birth certificate PERSON 1666<sup>+</sup>.

**6. FRAUD:** Capitalising from claims using our identity CAPS PERSON NAME as subject in Bad Counting practices. Its rape & pillage, global Bond Funds, that are Ours.

False data-base claims. Life is true data. Spoken Word.

BELT12 trespassed and forced a unlawful arrest on Joe on the 12<sup>th</sup> May, without reason, paperwork, no warrant or bail - FRAUD.

**7. BULLYING:** By pumping themselves<sup>UP</sup>, these cops, the many, forcefully steam roll and gas lit. Our willing words are shut down. 'If u have anything to say, explain in the court' and a lawyer lies for u! unless WE present ourselves to a death ear. They, Police, refusing to recognise other standings. Rejecting Compassionate Communication. To be Heard, listening to one another to meet ones need for remedy and Peace. - with their company body armory, they bodily charge like a bull for the man... (eg. protest).

**8. THUGGERY:** Brutality - pushing through their threats.

Police were not conducting business, not acting through duty.



The Police THUGS believe it's OK to physical enFORCE themselves, trained to do so. Hand cuffing, pepper spray, molesting 1961 Crimes Act section 48, Self Defence.

Before moving on NgAngA played the 1:23 minute video of the incident. That clearly shows all the abuse of these 13 claims, on the 12<sup>th</sup> May.

**9. ASSAULT:** Brutal physical attack with Tort. Harm, Injury, Damage, CRIME, 12<sup>th</sup> May BELT12, pushed me over the print bin. Inside the Gallery, the stage, NgAngA re-enacted the assault, the camera video, giving the Assessors a clearer picture of the incident. Police assaults leave a trail of injuries behind, some permanent, they are unaware of and don't care. Can U imagine the robotic cops? in the future.

NgAngA read to the Assessors an email from nurse Diane Soman that injuries from BELT12 are severe, especially left thumb. Damage to the thenar eminence, unable to put any pressure on this area or touch, restricting all movement. Was a two fold injury. The painful symptoms have severely limited NgAngA's use of his left hand. This will take some time to heal. (refer to photos.)

From there NgAngA gave further evidence, read a email response from Ben Weavers assault at the rear of Takaka POLICE station in Dec 24. Held down by Greg from Mental Health as BELT12 beat Ben blood streaming from his nose, requiring medical attention. No reason for assault as is often the case. For many in the Bay. Thuggery is only getting worse as the

NgAngA continued saying... 'I could gather countless testimonies claims against these three - and the many around the world. These criminal act-behaviours are occurring constantly, as the Norm's are addicted to their consumerism and distractions. Watching T.V while Police rape and pillage occurs in their neighbourhood, worldly. Being aware of this pushes Me even stronger to end this ABUSE...

These Sick, lost Souls in their dark shadows, cruelty goes well beyond the physical abuse, it's the mental, emotional and Spiritual abuse that holds on, until J&E can process it out. Not easy to forgive for most...

**9. ASSAULT:** Attempting to rescue Joe's key to Protect the theft of his automobile and special documents in, I followed the unlawful handcuffed arrest to the door only to be pushed over 'Assaulted' my Print display on 12<sup>th</sup> May by BELT 12. Caused Harm, Injury and Damage (CRIME) he returned next day, no avail to summons Me for 'Police Obstruction' ha. Back next day with his senior (RCB110) Ray Clapp blasting in, to summons, unlawfully seized my phone in fassel to obtain video evidence of the Assault on 12<sup>th</sup>. Managed to have video transferred to BELT 12's phone or lose for at least 3 months he said or ever, another Crime on the 14<sup>th</sup>. These Police Assaults leave a trail of injuries behind, they are unaware of care. I played this 14<sup>th</sup> phone Assault video to the Assessors to see and hear. Couldn't use left thumb after this Assault.

**10 Tort:** Physical injury to body, the Tort, can be ongoing. BELT 12 injured Left thumb in both attacks, the 14<sup>th</sup> May with Ray Clapps assistance. Previously in 2020 BELT 12 attempted to break my left wrist, then dislocate my left shoulder along with (JDS549) Jonathan Davies. My judo practices saved long term injury. I was abducted-kidnapped unlawfully jailed in Nelson, brutally handcuffed, behind 2hrs in cop car. example of the Thugs abuse---



**11 TREASON:** All Police Acts and behaviours are Treasonal from 1986 stepping out of CROWN into private Corporated Police N.Z. Co # 300001205 and Worldly, the Police, Prosecutors, NZBN: 9429041909966 & D-U-Ns 590216123

lying Lawyers, judges-agents... All guilty of TREASON these other Claims in the TRUE Peoples Gallery (cont). Why do People still allow this to happen? Right Now, they, the government are slapping so hard to Wake-Up to ourselves. May the few become the many - may the many become US All.

**12. TYRANNY:** These insecure agents pushing distorted service as absolute power, dictating a Law of their own. Infiltrating our safe space without our invitation - consent. WE've consistently rejected their presumptions and assumptions. The Brethren Brotherhood extending via Nepotism, special privileges with their clan. While targeting anyone a threat. WE've seen at protest how these Police attack like packs of hyenas. Savage animal behaviour, not humane. Forcing tyranny over our mind.

**13. BREACHING the PEACE:** Not being Peace Keepers, these Tyrants disturb our Peace in the Safe Heavenly Haven, unnecessarily breach their own laws and oath. With just flashing lights and sirens, for what a passengers seatbelt. Today it's become just their armored appearance. Due to my stance, refusing public conformity. These three, tyrannies of slavery unfolds here in a harrowing exhibition.

This sums it all up, the videos speak for themselves with attitude.

(hon. James CR) On hearing and seeing NgAra's evidence and the absence of the three offenders, who surrendered all rights of reply. Like, now, to put it to the Assessors (US) for a show of hands regarding; Brenton Edwards, Jonathon Davies, and Ray Clapp. Are they Guilty or not of the 13 claims presented. YES! all nine(9) present agreed on the outcome of GUILTY, vocally and raise of hands, unaimously GUILTY. That's GOOD enough for Me!'

What was known as Murderous Bay and still is under Police occupation. Today WE've finally cut the strings of their Racket, where they can no longer serve. This process / Tikanga is putting an end to the Racketeering. WE are sending the Murders of the Bay and Beyond away for the GOD of All.

Prior to executing remedy, has anyone else like to share related experiences to these claims?'



(James McKay) 'Oh! by the way, right now Ray C. is around the corner at the Courthouse Cafe having a cuppa' NgA- he is caught up in the courting injustice system. WE are a Just Gallery, he was invited...

Just over a year ago I was asleep in my home around 2-3<sup>00</sup>am. Car rolls in high beam lights ablaze. I get out of bed. This young woman yells out 'I'm staying here tonight!'. Still half asleep I replied. Fk'off grabbed my slug gun. She took off, about an hour<sup>+</sup> later, (after woman 111 call about gun?) the phone ring 'local cop - come out on the road, lie down on the hands behind your back' I did, this bald head cop pounded on my back knees first and my arm out of it socket. All of a sudden I was surrounded by armed offenders from over the hill with machine guns. They had already broken my arm, I was in such pain

(James McKay) cont:.. I still can't scratch my burn. I depend on my hand arm, as a home carver, my livelihood. Yes from NgAngA's video it was BELT 12 Brenton who assaulted me, I confirm.

After 6 months in remand was back in court. It was revealed my rifle was a protective air rifle identified it was unloaded. Judge said 'Go home now.' sent out on the street. No compensation, simply, laughed at and ignored.

(NgAngA) Thanks, James, like I've said, these trained gang bullies, attack the wrist and shoulder in arresting, that's common. Anyone else.

(Zanthe) On the 1<sup>st</sup> December 2025, Jonathan Davies and two large armed Nelson Police, fabricated a multiple breaches on Me, from My Ex, on custodies. It was very late at night. Harassing as they demanded my attention. I woke in my pyjamas, dazed, also with my period. They abducted / kidnapped Me. My daughter and a visiting girl friend still asleep. They wouldn't allow Me to go back inside to change, insisting I come down the station. Lying, it wasn't Takaka I was escorted 150<sup>th</sup> km over the Hill to Nelson cell. I declared no consent. Unlawfully, no paperwork, - warrant. On arrival, forcefully took my handprints, my DNA. and blood from my body.. So stressful, scary, I AM only 56kg. with four 100kg officers on top of Me...

Next morning feeling anxious, exhausted, before d. P. who wouldn't identify himself when I asked. Respected my name as Crown Zanthe. Then crossed out my claimed name on paper.. Perjury. Placed on bail, changed back into soaking pyjamas then pushed

(Zanthe) cont... out the door. So de-humanising experience to say the least, with no call out, push out on the street to find my way home 150+ km away, no money, no phone, A common cruel masonic practices. Feeling unsafe with the Police and being targeted. I AM looking to move out of the Bay to Richmond in 3 weeks. Will that be any different? Finally feel safe here today, heard.

(NgAng A) Thanks Zanthe, I feel for U. Hey, Joe, I know U have been through the hell of hells, would U like to share?

(Joe) Sure, this could be a long true story, I'll make it short as I can. From having no previous police engagements. I had 15-20 unproved attacks since 2022. First arrived in Golden Bay in 2023. These local police detained me on most of these after these attack. Not including 15 months of constant surveillance. Harassments stronger from 2024 to now. Scars of all kind are left. General disappointment of the dangerous institutional network.

Bold bald heads, out of uniform and integrity, - out of duty. I offered BELT12 my blue cap earlier. Here, I AM showing U my damaged clothing from various assaults in the Bay from these 3 police. - 1<sup>st</sup> December 2023, went to simply collect my seized van keys. I have today witnessed police camera disclosure of the assault BELT12 and RAY.C. executed at the back door of the Takaka police station. Forcing me into their cell. Several other attacks and property theft are recorded through the Takaka town surveillance inside and outside of stores.

In GOD's Perfect Timing: Currently this de facto N.Z. government; parliament is fast tracking to rid the need for a warrant to trespass and arrest, invade our private properties. IIC. may ask?.. Why has it degenerated to Taser and Pepper Spray violent attacks on the People? Do your research. In brief:

Taser - having these weapon at hand, out of specific policy misunderstanding, cognitive biases, or misinterpretations of legal thresholds and frustration. Most police believe their unlawful actions are justified, while they violate policy. An individual, non-compliance, steps aside, runs away as evasive or escaping not assaultive. Deploying a weapon purely to stop their flight violates policy. Misapplying Statutory Powers of entry and arrest. The charging police with Tasers or Pepper Spray is the threat. Not the individual running away, isn't an imminent risk. Police relying on physical or mechanical force rather Compassionate Communication and lower-level containment strategies.

Pepper Spray - Illegal or unjustified spray stem from misapplying tactical guidelines, overreacting to stressful situations, or failing to de-escalate. This disproportionate, unnecessary, or retaliatory, the police actions are classified as unlawful. e.g. spraying people who are already handcuffed, secured, or even locked in a holding cell, posing no threat. Invading Peoples homes, spraying anyone in sight, young children etc animals, pets. And so forth...

Time Haz Kurn NOW to end this Mafia/Mason Racket. This case represent the many is cutting the Strings. Enough's Enough! Children; young & old lost in cyber world videos (Mafia Life) evolving to a enforcement officers to professionally 'Hunt People' in the Real World.

**RESOLUTION: Restorative Justice**

(hon James CR.) Called to give directive for Restorative Justice remedy for territorial harm, injuries, and damage; Compensation.

(Joe) 'For territorial harm, includes US, these 3 be given so many hours to clean up Takaka Hill Road, the rubbish. Restoration repairs - Roads, Rivers is genuine service. Food forest planting alongside rivers.

(hon James CR) From their (govt') man made up Laws in dispute, the government - police ALL need to resign and make it public e.g. NZ Herald, Post newspapers. They publically apologise for their behaviours.

Clean out every compost toilet from Top of North Island to the bottom of South Island of Aotearoa, Land of New Zeol. They created the shitfull, 'shithouse' situations (not US) to clean up their mess, along with any other messes. Have them Servitude for the rest of their lives. Fail to perform (execut<sup>or</sup>), Return wealth to where it need to be.

(Robyn) To be countable to the People, they have injured, harmed and damaged - physically, emotionally, mentally, and Spiritually.

(Joe) Come in with the 'Minerals Act.' <sup>NgA</sup> ~~He~~, the People, are the main mineral requiring repair from these abusers.
